HARRY A. NOTTINGHAM PARK RESERVATION POLICY

The Town of Avon requires notification of picnics or gatherings in Nottingham Park of 50 people or less. Anyone wishing to use the Park for a picnic or gathering of more than 50 people must complete a Special Event Permit Application with the Special Events Department of the Town of Avon.

- I. <u>Picnic Permits</u> are required to be submitted when 50 or less people are planning to use Nottingham Park. Picnic permits are issued to groups who need no special assistance from Town personnel other than securing the space.
 - A. Fees: \$25 processing fee. A clean-up/damage fee may be assessed if the area is not left in an acceptable fashion. Trash and or recycling may not be left next to receptacles and any excess trash or recycling shall be disposed of or carried out by the Applicant.
 - B. Power is not provided.
- II. <u>Special Event Permits</u> are required when 50 or more people are involved, and technical assistance is required from Town personnel. Please visit http://avon.org/2042/2019-Special-Events or contact the Special Events Department for more information.

PLEASE BE AWARE OF THE FOLLOWING RULES THAT APPLY TO ALL USING HARRY A. NOTTINGHAM PARK

- I. ALL DOGS MUST BE LEASHED AT ALL TIMES
- II. NO DOGS ALLOWED IN THE WATER
- III. PETS ARE NOT ALLOWED AT SPECIAL EVENTS
- IV. NO SWIMMING OUTSIDE OF DESIGNATED AREAS
- V. NO HUNTING, ARCHERY, GOLF, AIRCRAFT OR FIREARMS ALLOWED
- VI. NO PERSON AGE 16 AND OVER SHALL ENGAGE IN FISHING IN THE PARK OR SPECIAL EVENT AREA WITHOUT A VALID COLORADO FISHING LICENSE
- VII. NO DRIVING OR PARKING ON THE BIKE PATHS WITHOUT SPECIFIC PERMISSION
- VIII. NO PERSON SHALL DRIVE, RIDE, OR OPERATE AT ANY TIME ANY MOTORIZED VEHICLE OR MOTORIZED DEVICE OF ANY TYPE WITHIN THE PARK OR SPECIAL EVENT AREA
- IX. POSSESSION OR CONSUMPTION OF ALCOHOLIC BEVERAGES IS NOT ALLOWED
- X. NO OVERNIGHT CAMPING
- XI. NO OPEN FIRES EXCEPT FOR COMBUSTION OF CHARCOAL IN FIREPITS OR GRILLS
- XII. NO PERSONAL FIREWORKS
- XIII. NO AMPLIFIED SOUND WITHOUT A PERMIT
- XIV. DAMAGES TO THE PARK AND ALL CLEAN-UP ARE THE RESPONSIBILITY OF THE USER
